From Shelter to Stability Tiffany: Persistence and Hope

A client came to our shelter with her children in early 2018. Tiffany was a single mother who decided to come to Cedar Rapids with her seven children, ages 5 to 17, for a new beginning.

She immediately registered all of her children for school so they were able to start that following week and then immediately began her journey in trying to find employment and housing. And a journey it was!

Tiffany quickly got hired and was able to qualify for our new rapid re

-housing program. As she was looking for housing, it proved to be difficult for a single mother with seven children. She struggled to remain confident, yet she remained steadfastly optimistic for her children, who also stayed positive through the ordeal. She talked with and supported her children

when they were struggling.

with each other. They were respectful to our staff; it was obvious she had done well by her children. It was clear that she wanted the best for her children and nothing less.

While staying at Willis Dady, Tiffany started a support group for moms in the shelter. She felt it was necessary for other women who have gone through similar struggles to be able to support each other while each continued to search for housing.

Most of the housing options were

too expensive, as she needed a house for such a large family. Once she was able to identify an appropriate house; her lack of income remained an obstacle. The agency who owned the house was concerned about

affordability, their ability to pay the rent and utilities along with other family expenses.

Tiffany began to look at other options and began to work on them. Each step of the way she worked hard at getting her finances in order so that she could have a place to live with her children.

Along the way, Tiffany's boss reached out and explained that he wanted to do whatever he could to help. Eventually, both our case manager and Tiffany reached out to him and advocated for her to receive more hours, and he gladly obliged. This was a major accomplishment! She then found and accessed other resources that would help her while staying in contact with the agency that owned the house.

Finally, after working with the agency, her boss, finding other resources and producing all of the paperwork that was required, Tiffany was able to secure the house that she wanted for her family. Through hard work and collaboration of everyone involved, her dream became a reality. She is now looking forward to spring and planting flowers in her garden.

Director's Notes Change in Seasons



The weather has been a hot topic this winter/spring, as the cold temperatures dragged on much longer than usual. For Willis Dady staff and clients, the extended winter season presented some challenges for accessing safe shelter. This was our third winter staffing the Community Overflow Weather Shelter System (COWSS), a short-term shelter available to anyone needing a warm bed on a winter night. Once again we worked with a large team of agencies, allowing us all to minimize duplication, and perhaps more importantly, to help clients access the most appropriate long-term supports quickly and efficiently.

This year, through the support of Linn County, the City of Cedar Rapids, and a generous donor providing an empty building space, we were able to operate November 15 to March 15. Staying open consistently allowed police and hospital employees on the front lines to bring or send clients to us as needed, without worrying about people finding the shelter closed or full for the night. While this was a big improvement in access over the past couple of years, the long winter

surprised us with a snowstorm the last week of March followed by temperatures below freezing well into April. A generous church opened their doors to people living on the streets for the two day snow storm, and our devoted winter staff came back to supervise the temporary space. Throughout the remaining cold weeks Willis Dady was able to open additional "overflow" beds within our already crowded shelter (sleeping on couches and cots in the middle of the full bedrooms) on days the temperature dipped below freezing, and other agencies did the same.

The experience of another winter overflow season highlights two points. The first is the continued generosity, faithfulness, and compassion of our community. When there is a need, we know we can find comfort and care from you, our friends. The second is the struggle to establish better solutions to the problem of homelessness. We know creating more shelter, even temporary collaborative shelter, is not a long-term solution. We know housing and supports are needed if we want to make a significant impact on homelessness in our area. But we also know there are people in need, for whom sleeping on the street for a night may result in death or serious injury. We are grateful that we've been given the resources to be able to meet these needs, and we will continue to seek better, longerlasting solutions to the crisis of homelessness.

Construction Has Begun On Our Shelter!

After that long, brutal winter, we are eager to begin work on the expansion! We've been awaiting building permits and hope that by the time you read this, that our contractor Woodruff Construction will have permits in hand.

What's been accomplished so far: The playground equipment has been removed. This was quite a job. We were surprised and glad to see how well cemented it was (and therefore sturdy and secure for even the most active kids to play on). The playground will be relocated once the construction is complete. In the meantime, there's another playground right on our block.

Next steps in the project will be arranging utilities connections from old to new structure. Then Woodruff will shore up the foundation of our existing building to make way for the basement excavation. After digging the basement, they'll dig the foundation for the family wing and construction will proceed from there.

We anticipate completion next winter at which time we'll move shelter and office operations into the new building. Then the existing building will be renovated.

We are beside ourselves with excitement and brimming with gratitude. Thanks to all who supported this project.

Updates From This Season's Overflow Shelter

The Linn County Community Overflow Winter Shelter System (COWSS) is organized a group of over 15 agencies that work to provide low-barrier shelter during the cold nights of winter. We use a harm-reduction approach to keep people alive until they are ready and able to engage with other housing services. Our mission is to provide safe temporary shelter during life-threatening weather conditions.

Avoiding duplication, together we provide overnight shelter to those who can't access other shelters. Those we serve may be ineligible for other shelters due to substance use or previous behavior issues, or the shelters may be full on a given night.

This past winter we were open for 122

nights, no matter what temperature it was outside. This is a departure from previous years, where the shelter only opened when the temperature dropped below a certain point.

This season, the overflow shelter served 470 unduplicated individuals, which included 308 men, 147 women, and 15 children for a combined total of 5,198 nights of shelter.

We thank all of our community partners, all of the donors who provided their time and resources to the shelter, our diligent and committed temporary staff of four, our volunteer-led planning committee, and everyone else who helped and supported the overflow shelter this last season.

Progress on Supportive Housing

In last quarters newsletter, we told you about our purchase and renovation of Welborn House, a supportive housing facility on Washington Avenue SE.

Supportive Housing combines affordable rent with case management to bring stability to people who are in poverty and struggle with ongoing homelessness. Fewer than 20% of our clients need this kind of intensive support – the vast majority need only temporary short-term help to get on their feet.

Physical and/or mental disabilities, substance use disorders and low income create instability. That instability leads to repeat evictions and cycling in and out of eviction, homeless shelters, hospitals and jail. Eviction makes it difficult to locate housing that's affordable — especially on a limited income, such as SSI or SSDI.

Our tenants will pay no more than 30% of their income in rent.

"A case manager is there to create a relationship, to build trust and help clients reach stability and identify future goals to work on, " says Alicia Faust, Support Services Manager. "We help them engage with the resources to become self-reliant. Maybe the goal is to stay clean and sober or to overcome

social anxieties ... really, it could be any number of things that have been holding this person back from a productive life."

In addition to Welborn House, we will provide four efficiency rentals of Supportive Housing in our new facility expansion. Welborn House is undergoing renovation by wonderful community volunteers. In addition, Willis Dady has been contracted to provide case management for five Supportive Housing units at the Crestwood Ridge apartments owned by CommonBond, which opens this fall on Edgewood Road.
